### COLUMBIA BASIN FOUNDATION

We, the undersigned, being over the age of twenty-one (21) years and acting as the incorporators of a corporation under the provisions of the Washington Non-Profit Corporation Act (Revised Code of Washington § 24.03) adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I

### **NAME**

The name of this Corporation shall be: Columbia Basin Foundation.

#### <u>ARTICLE II</u>

#### <u>INTENT</u>

The Foundation is intended to be an organization which is exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) and which is an organization described in Section 509(a)(3) (or corresponding provision of any future United States Internal Revenue Law). All terms and provisions of these Articles and all operations of the Foundation shall be construed, applied, and carried out in accordance with such intent.

#### ARTICLE III

#### **PURPOSE**

The purposes for which the Corporation is organized are:

1. The Corporation is organized exclusively for charitable, religious, literary, scientific and educational purposes as set forth in Section 501(c)(3) of the Internal Revenue Code including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of such Code.

- 2. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation.
- No substantial part of the activities of the Corporation shall be the carrying on of propaganda (no part of the activities of a private foundation may be used to influence legislation as defined in Section 4945), or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- 4. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or (c) by a nonprofit Corporation organized under the laws of the State of Washington pursuant to the provisions of RCW Title 24.03.

## ARTICLE IV

# TERMINATION.

Upon the termination, dissolution or winding up of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all assets of the Corporation to such organization or organizations organized and operated exclusively for charitable, educational or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Court in the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.

## ARTICLE V

# INCOME DISTRIBUTION

The Corporation shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code. Further, the Corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, nor retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue

Code, nor make any investments in such manner as to incur tax liability under Section 4944 of the Internal Revenue Code, nor make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.

## **ARTICLE VI**

### **BOARD OF DIRECTORS**

The Corporation shall be organized on a non-stock basis and shall have no members. The authority for all affairs of the Corporation shall be in a Board of Directors who shall have and may exercise all the powers of the Corporation as permitted by federal law, state law, these Articles of Incorporation, and the Bylaws of the Corporation as from time to time in effect. The Board of Directors shall be nine (9) to fifteen (15) in number, and their names and addresses of the initial Directors are as follows:

Similarly, any general or specific references to the laws of the State of Washington shall be deemed to refer to the laws of the State of Washington as now in force or hereafter amended.
